Executive Summary

The City of Columbia and the Columbia Professional Firefighters I.A.F.F. Local 1055 reached a tentative agreement on a new three-year labor contract. The contract requires City Council approval.

Discussion

City of Columbia management representatives and representatives of the Columbia Professional Firefighters I.A.F.F. Local 1055, including employee bargaining committee members, participated in a process to renegotiate the current collective bargaining agreement that expires on September 30, 2022.

1055 represents Firefighters, Fire Engineers, Fire Lieutenants, Assistant Fire Marshalls and Fire Captains in the Columbia Fire Department. A tentative agreement has been reached and members of 1055 have ratified the proposed contract.

The proposed amendments include the same proposed pay adjustments included in the FY 2023 budget.

If approved by council, the contract will be in effect October 1, 2022 through September 30, 2025. The contract also includes an annual compensation/wage reopener clause. The proposed agreement is attached.

Fiscal Impact
