The City is requesting \$100,000 in HOME funding to continue its Home Ownership Assistance Program (HOA). The 2023 HOA program will provide up to \$10,000 of home purchase price for down payment assistance and closing costs. The City will also spend up to an additional \$500 to eliminate lead hazards.

Funds are available to first time home buyers, defined as someone who has not owned a home within the last three years or is a displaced homemaker. The program remains important to the City in stabilizing neighborhoods. The program requires home buyers to repay a pro-rated proportion of the funds if they do not continue to own and occupy the purchased unit, as required by HUD, for a ten year period. The program helps build property values through increasing the home ownership rate in neighborhoods.
