Re: North 763 CID - End of Fiscal Year Report (FY 2023)

### **Executive Summary**

The North 763 Community Improvement District (CID) is submitting its end of fiscal year report, which is required by State Statute.

#### Discussion

The North 763 CID was established by ordinance on December 15, 2008. Pursuant to Section 67.1471.4 of the Revised Statutes of Missouri "Within one hundred twenty days after the end of each fiscal year, the district shall submit a report to the municipal clerk, the Missouri department of revenue, the state auditor, and the Missouri department of economic development. The report shall state the services provided, revenues collected, and expenditures made by the district during such fiscal year; state the dates the district adopted its annual budget, submitted its proposed annual budget to the municipality, and submitted its annual report to the municipal clerk; and include copies of written resolutions approved by the board during the fiscal year. The municipal clerk shall retain this report as part of the official records of the municipality and shall also cause this report to be spread upon the records of the governing body."

Enclosed is what was submitted by the North 763 CID.

The communication from the Van Matre Law Firm transmitting this report indicates that "on or about September 1, 2023, the District submitted its annual proposed budget to the City of Columbia, Missouri State Auditor and Department of Revenue." The City Clerk's Office has no record of this submission and has informed Richard Hicks with the Van Matre Law Firm. Upon receipt of that submission, it will be included on a future council meeting agenda. It appears Resolution No. 2023-6 that is a part of the documentation for this report is related to the FY 2024 annual budget referenced.
