Re: Setting a public hearing: proposed construction of sanitary sewer rehabilitation project

#10 in the Bear Creek area

Executive Summary

Staff has prepared for Council Consideration, a resolution to set a public hearing for April 3, 2023, concerning the Sanitary Sewer Rehabilitation #10 Project. The proposed sanitary sewer system improvements will consist of rehabilitation of approximately 53,000 linear feet of sewer line in the Bear Creek area. The resolution estimate for this project is \$7,025,000 and will be paid from the Sewer Utility Revenue Bonds approved in the 2013 ballot and other sewer revenue funds.

Discussion

The scope of this proposed sanitary sewer system improvement project consists of rehabilitating sewer pipe and lateral connections to the sewer main located primarily along and adjacent to the Bear Creek in Columbia. See the attached Location Map. Approximately 53,000 linear feet will be rehabilitated to repair structural deficiencies and to reduce Inflow and Infiltration (I&I) into the sewer main. A large amount of the pipe to be rehabilitated is the sewer trunk line itself, where the pipe sizes are greater than a typical residential eight-inch sanitary sewer main. The project is anticipated to begin in late 2023.

The proposed rehabilitation project is a continuation of annual efforts to repair existing sewer infrastructure and reduce I&I as part of the Wastewater and Stormwater Integrated Management Plan. Work includes lining approximately 53,000 linear feet of aging sewer main identified by Sewer Utility staff. The identified sewer trunk lines are either vitrified clay pipe or iron pipe adjacent to Bear Creek and prone to infiltration or failure. Rehabilitation of these lines will reduce inflow and infiltration (I&I) and the occurrence of stoppages. Reduction of I&I is part of the ongoing effort to reduce the number of backups into buildings and sanitary sewer overflows. Rehabilitation of sewer mains could occur throughout Columbia. As shown on attached the Location Map the large trunk sewer along Bear Creek has been identified because of its age, proximity to the creek and poor condition. Because the work includes larger lines that carry significant flow, bypass pumping will be necessary for much of the project.

An Interested Parties (IP) meeting was held January 26, 2023, for the primary affected areas. No residents or customers attended the meeting. Staff communicated with others who were interested in the project but could not attend the meeting. Staff will work with people that might be affected or with any issues that might arise due to the lining of the sewers and associated bypass pumping. The resolution estimate for this project is \$7,025,000 and will be

paid from Sewer Utility Revenue Bonds approved in the 2013 ballot and other sewer revenue funds.
