Re: Amending Ordinance 024962 as it Relates to the Acquisition of Easements for the Construction of Portions of Sidewalk, Pedestrian Crossings and Pedestrian Crosswalks along the West Side of North Stadium Boulevard (Route E) between the I-70 Overpass and Cottle Drive and Correcting Property Interest to be Acquired.

#### **Executive Summary**

Staff is requesting council to amend Ordinance 024962 as it relates to the acquisition of easements for the construction of portions of sidewalk, pedestrian crossings and pedestrian crosswalks along the west side of North Stadium Boulevard (Route E) between the I-70 overpass and Cottle Drive and correcting property interests to be acquired.

#### Discussion

Ordinance 024962 incorrectly identified a property interest to be acquired from American Truck Repair LLC. The original Ordinance 024962 identified the need for a Permanent Street Easement #2. This will correct that interest from Permanent Street Easement #2 to a Temporary Construction Easement.

The North Stadium Sidewalk project design will include the following improvements:

- (a) Construction of a concrete sidewalk to fill in sidewalk gaps along the west side of North Stadium Boulevard (Route E) in northwest Columbia. The south end of the proposed sidewalk will start at the existing sidewalk at the Stadium overpass of Interstate 70. The north end of the proposed sidewalk will start at the existing sidewalk at the Break Time gas station.
- (b) Improvement of the pedestrian crosswalk at I-70 Drive Northwest and at Primrose Drive.
- (c) Construction of a pedestrian crosswalk across Stadium Boulevard north of Aaron Drive with a sidewalk connecting to the Cosmo Fitness trail.
- (d) Construction of a pedestrian crosswalk across Business Loop 70-West at Cosmo Park with a sidewalk along the south side of Business Loop 70-West connecting to the crosswalk at the Stadium Boulevard overpass of Interstate 70.
- (e) Construction of a sidewalk to fill in the sidewalk gap at the northwest corner of the Rose Drive and Stadium Boulevard intersection.
- (f) Construction of a sidewalk to fill in the sidewalk gap at the southwest corner of the Aaron Drive and Stadium Boulevard intersection.

Five (5) permanent sidewalk easements and seven (7) temporary construction easements will be necessary for the construction of the improvements.

The total preliminary cost estimate for this project (design, easements, and construction) is \$600,100. The project will be funded with the 1/4-cent Capital Improvement Program sales tax.

The project is scheduled for construction in fall of 2022.

#### Fiscal Impact

Short-Term Impact: The total preliminary cost estimate for this project (design, easements, and construction) is \$600,100. The project will be funded with the ½-cent Capital Improvement Program sales tax.
