Re: Approving Amendment #1 to the Collective Bargaining Agreement between the City

and Laborers' International Union of North America, Local 955 (LiUNA).

#### **Executive Summary**

Staff is seeking Council approval of Amendment #1 to the Laborers' International Union of North America, Local 955 (LiUNA) Collective Bargaining Agreement (CBA) that incorporates newly LiUNA represented positions of the Water Distribution Division into the CBA and approved pay scale.

#### Discussion

City of Columbia management representatives and representatives of Laborers' International Union of North America Local 955, including employee bargaining committee members, participated in a process to renegotiate the current Collective Bargaining Agreement (CBA) scheduled to expire on September 30, 2027.

In October 2023, Council recognized identified classifications within the Water Distribution Division of the Utilities as an additional work unit of LiUNA. This amendment adds the job titles to the CBA and further defines maximum number of stewards allowed. Finally, the Water Distribution employees agree to rescind and reimburse the City all salary increases that were provided to Water Distribution employees as authorized by Council on June 11, 2023 and again on October 1, 2023. Following repayment, Water Distribution employees will be incorporated into the City approved pay scale, identified as Exhibit A, for LiUNA employees. Employees must be actively employed in the same position on the effective date of pay rate change as identified in Exhibit C.

Staff has prepared separate legislation that officially recognizes these employees in the City's classification plan.

Council approval is required for this amendment.
