Comments Regarding Chapel Hill-Fairview Roundabout

After attending the December 14 session regarding the Chapel Hill-Fairview Roundabout, I continue to have very serious and strongly held reservations about the proposed project. I detail these concerns below:

1. Lack of demonstrated need—As someone who has lived in the vicinity of the intersection for more than 20 years, using it on a daily basis for access to and from my home, and commuting to and from MU during the morning and evening rush hours, I have direct experience with traffic conditions. Any delays at the intersection occur only during the Monday-Friday evening commute and are at worst minimal. Before 4:30 p.m. and after 6:00 p.m. and during the weekend, traffic is never delayed.
2. Topography—the intersection is located at the top of a relatively steep hill. Like the roundabout at Fairview and Rollins, the incline will almost certainly limit visibility. Winter weather, which often impedes traffic on Chapel Hill, is likely to complicate this concern. The prospect of vehicles traveling at or above the posted speed limit as they enter an area of poor visibility or weather-related impediments should be a cause for concern.
3. Safety—I have heard only anecdotal claims of hazards associated with the current configuration, but have never personally observed a crash at the site. The roundabout, however, will introduce real hazards. In addition to the point above, the proposed design is problematic for pedestrians (including young children), runners, and bicyclists who regularly use the intersection. The displaced crossings will be challenging for all of these parties to navigate safely. A final hazard is to the parents and preschoolers who stop and disembark at the daycare center on Fairview.
4. Takings of property and amenities—the proposed design includes the taking of private property within the Chapel Hill Estates subdivision as well as the loss of amenities associated with commonly held property within the subdivision. We were told by a representative of the Public Works Department that compensation and redress of these losses was merely subject to negotiation and not an obligation of the City.
5. Cost—at a time when the City of Columbia has many pressing needs and limited funds, there would seem to be many alternative uses with a higher priority.

Before proceeding, I sincerely hope the Department of Public Works and the City Council will give serious consideration to the concerns expressed herein as well as to others raised by residents. Roundabouts can be practical solutions to many traffic-related problems, but the intersection of Chapel Hill and Fairview does not appear to be one of them.

Dr. Hussain,

We are unequivocally in opposition to the proposed roundabout at the intersection of Fairview Road and Chapel Hill Road. It is our position that the issues enumerated in the commissioned study by Allstate does not warrant draconian action of placing a roundabout in an established residential environment.

We have three major concerns; 1) safety, 2) entrance to Chapel Hill Estates Subdivision and 3) financial impact.

SAFETY: The study commissioned by the city acknowledges that the existing four way stop does not possess any safety concerns and is superior to other alternatives. It is difficult to refute that a vehicle coming to a complete stop is a safer proposition than a vehicle traveling at 25 mph attempting to navigate a roundabout. The sight issue associated with the steep incline of Chapel Hill Road is also a safety concern. Vehicles traveling west entering the roundabout at 25-30 mph is problematic, especially if they turn north in front of the day care school located at the top of the hill.

CHAPEL HILL ESTATES ENTRY: The proposed roundabout totally dismantles the integrity of the entrance to Chapel Hill estates, inclusive of the landscaping, mature coniferous trees, wall and landscaped median island. The proposal essentially places the roundabout in the entry to the subdivision. The wall, landscaping, and median island were designed to address the environmental issues associated with the intersection of Fairview and Chapel Hill Road. The neighborhood has a significant financial investment and sweat equity in the creation, maintenance and design of the entry to the subdivision.

FINANCIAL/INVESTMENT LOSS: The proposed roundabout will result in the consequential reduction of property values for lots located on Fairview road within the subdivision. It is conceivable that all homeowners in the subdivision will see a reduction in the value of their property. Lot 1 and lot 68 of the subdivision will suffer irreparable financial damage.

The commissioned study reflects that there is no significant delay in traffic flow in the AM peak time and there is only 89 second delay at the PM peak time for westbound traffic. The question to be answered is: "Is the perceived problem ripe for the expenditure of 1.1 million dollars (conservative estimate) of taxpayer's money". We think not.

Thank you for hosting a forum on December 14, 2023 and being available to discuss the proposal. Please keep us apprised on any further development or changes on the project.

1. We believe that the proposed roundabout will present increased safety concerns for pedestrians and cyclists in our neighborhood.

The intersection of Fairview and Chapel Hill is a residential neighborhood crossing and it is the only entrance or exit to Chapel Hill Estates. The planned roundabout would make it perhaps the only roundabout in Columbia where such a neighborhood entrance would be incorporated into a roundabout with continuously moving traffic.

Drivers entering or exiting a roundabout are moving and primarily focused on avoiding other moving vehicles in the roundabout. Pedestrians and cyclists are a secondary concern. The intersection of Chapel Hill and Fairview is active with pedestrians and cyclists - including a school on the northeast corner. For safety reasons, we believe that any effort to improve traffic flow through the intersection should require vehicles to make a complete stop.

In addition, the proposed roundabout would be in close proximity to residential driveways. This would present the likelihood and increased safety concern of drivers backing into approaching or exiting traffic.

2. We do not agree that a roundabout at Chapel Hill and Fairview Road will achieve significant improvements to traffic flow.

As residents of Chapel Hill Estates, we can attest that flow through the intersection has not presented significant delays. This observation is based on many years as daily commuters – including traveling west on Chapel Hill during peak evening periods. The greatest challenges to traffic flow have been during the periods of construction projects such as the expansion of Nifong Boulevard that diverted traffic to Chapel Hill Road. Since the completion of those projects, we have not experienced significant delays.

3. The proposed roundabout will greatly impact the appearance and value of Chapel Hill Estates properties in a negative way.

The proposed roundabout would require the elimination of mature trees that have been cultivated over decades. These trees provide great value for their appearance and sound barrier characteristics. This loss would substantially affect the property values of all residents of Chapel Hill Estates and especially those in proximity to the proposed roundabout.

For these reasons, we respectfully request that additional input be solicited from residents of the area and that alternatives be explored before further action is taken.

Hello,

I am not in favor of a single lane roundabout at Fairview and Chapel Hill with the strongest conviction. Single lane roundabouts are not safe nor efficient in my experience. They are also difficult when you have a main road with a lot of traffic intersecting with a less used round, such as Chapel Hill compared to Fairview, especially around 5 pm. You will get cars slowing down but not yielding to other cars at the intersection if they are going straight on Chapel Hill, as the same thing happens at another single lane roundabout at Fairview and W. Rollins (btw, I travel that intersection 2 to 3 times a day and see two near accidents every week, that is a bad intersection). There is also a preschool or daycare at that corner and when parents drop off and pick up their children they park on both sides of the street, this will cause another problem for a single lane roundabout at Chapel Hill and Fairview. There must be a better solution, please do not impose this upon us, we have enough roundabouts and speed bumps, the city is becoming less livable because of these changes.

I received the letter about the roundabout that Columbia intends to install at the corner of Chapel Hill and Fairview. I will not be able to attend the information meeting. The corner is currently busy during the morning and evening rush hours, but the rest of the time it is easily managed by the four-way stop. As evidenced by the "roundabout" at Rollins and Fairview, all that will likely happen is increased accidents or near accidents. It certainly won't be safe for pedestrians or bicyclists. On more than one occasion, I have nearly been hit at Fairview and Rollins by a driver "sailing" thru the intersection. Although you say there will be adequate room for commercial vehicles and buses to make the turn, I don't believe it.

The city's proposal to spend in excess of \$1,000,000 for a project to address a traffic flow issue that is limited to a short window, approximately 5:30 during evenings on weekdays, is a fiscally irresponsible use of taxpayer money. More specifically, the hill, smallness of the area, nursery school, infringement on personal property - all make it highly problematic for an effective roundabout in this location. In addition, there have been snow and ice at the stop sign as one exits Chapel Hill Estates at Fairview and attempts to cross Chapel Hill Road, causing one's automobile to skid. With the elevated

concrete circle in the intersection, the driver will be unable to drive his or her automobile straight across Chapel Hill Road when no traffic is near. Moreover, the city rarely makes cleaning of secondary roads a priority during inclement weather, making the exit onto the roundabout from Chapel Hill Estates more dangerous. For these reasons as well as others, we adamantly oppose the construction of a roundabout at this location. In addition, our HOA recently repaired the brick structures and purchased new lighting for the entrance to Chapel Hill Estates - both conceivably could result in wasted resources for the Homeowners.

Please listen to the property owners in the area, the taxpayers, and decide on an alternative plan that is less invasive and less cost prohibitive for addressing the traffic flow that presents an issue during a short window, mainly on week days around 5:30 p.m. The installation of a roundabout is not a viable solution; "One size does not fit all."

2. We do not agree that a roundabout at Chapel Hill and Fairview Road will achieve significant improvements to traffic flow.

As residents of Chapel Hill Estates, we can attest that flow through the intersection has not presented significant delays. This observation is based on many years as daily commuters – including traveling west on Chapel Hill during peak evening periods. The greatest challenges to traffic flow have been during the periods of construction projects such as the expansion of Nifong Boulevard that diverted traffic to Chapel Hill Road. Since the completion of those projects, we have not experienced significant delays.

3. The proposed roundabout will greatly impact the appearance and value of Chapel Hill Estates properties in a negative way.

The proposed roundabout would require the elimination of mature trees that have been cultivated over decades. These trees provide great value for their appearance and sound barrier characteristics. This loss would substantially affect the property values of all residents of Chapel Hill Estates and especially those in proximity to the proposed roundabout.

For these reasons, we respectfully request that additional input be solicited from residents of the area and that alternatives be explored before further action is taken.

Dear Mayor Buffaloe, Councilman Foster and Dr. Hussain,

We want to voice our opposition to the installation of a roundabout at the intersection of Chapel Hill Road and Fairview Road. We have lived in Chapel Hill Estates (CHE) for the last 19 years and, in that time, have driven and walked through this intersection tens of thousands of times. While we have not conducted small numbers of methodical observations of traffic like those of Allstate Consulting, we have used this intersection repeatedly under a wide range of weather and traffic situations and have developed some habits to guide us safely through the intersection. A roundabout with cars driving around a circle at varying speeds under varying road conditions would exacerbate all

the safety issues we have personally and repeatedly observed with the current 4-way stop.

First, during inclement weather when Chapel Hill Road is slippery, one can usually drive on Fairview from this intersection into town or to return home. Many residents of CHE who work in town or at MU do this because the streets involved are not so steep and are more reliably maintained. In fact, a roundabout will make traveling through this intersection more treacherous than simple stop signs.

Right now I do not cross the street as a pedestrian when there's traffic because so few drivers pay attention to pedestrians. And I'm a traffic-savvy adult. What about children or bikers or folks who unfamiliar with aggressive drivers during rush hour? Trying to avoid moving cars who are trying to avoid other cars will make this even more unsafe for walkers because of all the movement involved.

Other issues include the facts that this intersection must be used by children, bikers and pedestrians who are traveling to visit Twin Lakes Park from the west and north. People doing this may not know that drivers are not very familiar with the presence of pedestrians and bikers in this residential roundabout.

Another safety issue is that drivers who travel though the roundabout from the west and east, and who are headed north, may not pay much attention to street conditions north of the roundabout. This is the location of the Day School where young children may be getting in and out of cars on both sides of the street. Even if the School's drop off point is moved farther north, drivers coming out of the roundabout would immediately have switch from looking for moving traffic in the roundabout to looking for children and adults in a school zone. Stop signs are much simpler from a human visual perception point-of-view. Ignoring how people drive will be critical in this roundabout at the top of a steep hill.

Lastly, there us some evidence reported to the City from a CHE resident that, except for a short time during the day, the delays at this intersection are minimal. When other east-west streets are occasionally blocked for construction purposes, traffic on Chapel Hill Road does increase. But is this worth the \$1.2 million dollar price tag for a roundabout of questionable merit? There will also be increased maintenance costs for clearing a roundabout of snow and ice in the winter...because that's when cars will slide out of control trying to stay in lane in a roundabout.

There are, I'm sure, many city residential locations where roundabouts do improve traffic flow and safety for drivers, bikers and pedestrians. But, a limited access roundabout at the top of a steep hill like Chapel Hill Road is probably not one of them.

We have lived in the Chapel Hill subdivision for 33 years. As a result we have a historical perspective, and hopefully some credibility, of the traffic patterns regarding Chapel Hill.

Please, respectfully consider our thoughts: The roundabout issue was debated 5 years ago downtown. I was present and many spoke with sound reasons against the round about then. Those same reasons haven't changed.

1. The present 4 way stop system has and continues to work well. I've never had to wait more than 5 minutes (even during rush hour) to climb Chapel Hill. The intersection forces vehicles from all sides to STOP and assess the intersection for cars, signaling intentions (blinkers), visibility and safe crossing of pedestrians, and bicyclists. I have never yet witnessed an accident in the intersection. It works! A round about of this smaller size will increase vehicle speed and the risks for the many pedestrians (including school children, walkers and bicycles to Twin Lakes from Fairview and Chapel Hill subdivisions.)
2. The 100 or so homes in the Chapel Hill subdivision will need to muscle their way into the downhill West to East rush hour flow which will be challenging to say the least.
3. I have NOT noticed a significant increase in rush hour traffic over the last 15-20 years. I've never had to wait more than 5 minutes max climbing Chapel Hill even during rush hour traffic. Forum to Scott Blvd. development has been stable for many years. This suggests that the cross through traffic has minimally increased.
4. Lastly, there is a school (preschool) that sits on the corner and cars are parked on both sides unloading small children twice daily over a period of 20-30 minutes. More than once I have personally had to come to a grinding halt as a 4 yr. old or sibling stepped out between cars at the preschool. Again, cars are forced to stop, especially the west to east flow that is on the downhill slant.

RE: Opposition to the Roundabout at Fairview and Chapel Hill Roads

We have been living in the Chapel Hill Estates for over thirty years and were one of the first ones to build in the subdivision. We have loved the location and our ability to leave the subdivision for work or errand. As a frequent pedestrian and bicyclist my wife and I are opposed to the proposed roundabout at Chapel Hill and Fairview Road. There are many reasons that it will be bad for our community and will not solve traffic issues at this intersection. It will make it more dangerous for pedestrians and cyclists. The closeness of the preschool, poor maintenance of the Rollins/Fairview roundabout and poor access out of the subdivision. This is a poor bad way to spend over a million dollars to replace the four way stop with something that is more dangerous and will not improve the egress from our neighborhood and contribute to pedestrian injuries and deaths.

1. This roundabout will be similar to the Fairview and Rollins roundabout. That structure is small and with broken bricks, broken cement in the road from heavy trucks and school buses. The small round brick is dirty, broken does not protect our wonderful community. Before spending a million plus dollars on another eyesore that is not maintained careful consideration should be given to other alternatives. If the city can't take care of this roundabout, how can we adequately service other new roundabouts.
2. Although roundabouts are said to be safer for car traffic, we have had few accidents and none fatal at our current configuration. However in a national study, roundabouts showed increased pedestrian and cycling accidents as cars do not have to stop at a stop sign. If no other cars are present are given the go ahead leading to increased pedestrian accidents. The car has the right of way! Should we not be projecting safety! Also, should we not be encouraging healthy lifestyles for our community which include walking, walking the dog, biking, running and other non motor activities. Families and kids walk to the Fairview School. Are we now promoting driving and global warming versus non polluting healthy walking? We live longer when we exercise such as walking. At a stop sign pedestrians/runners are given the right of way in the roundabout this is not always done. Compliance is better with a stop sign. In roundabouts, there is a higher injury rate of pedestrian accidents and deaths.

Roundabouts increase safety for automobiles but decrease the safety of pedestrians, cyclists, and ADA individuals as cars will not be required to stop.

3. The higher entry into the roundabout from the west encourages speeding in the roundabout while stop signs slow traffics.
4. I commuted to my job by going to the stop sign at the end of the subdivision and turning east going to Forum and the University. With a roundabout, increased traffic from the west will lengthen the time to turn right. Also with the increased elevation on the west speed of the cars is higher leading to a potentially dangerous situation. At peak times our subdivision traffic will have a hard time

breaking into the roundabout as traffic from the west will dominate the circle. Traffic will slow down, currently we take our turns. For our subdivision we will be shut out of the roundabout in the morning or have poor access. The same process will occur from the Fairview side of the roundabout during the "5 minute" rush hour around 5 pm. I came from the hospital everyday about that time and what made it doable into our subdivision was the left hand turn lane.

5. Destroying our Chapel Hill Neighborhood entrance stone and middle island will decrease land values. The preschool is a historic building and property the roundabout will not enhance that property and houses abutting the roundabout also will have lawn taken away. The road will be closer to the houses and the preschool with increased noise and light pollution. All of this will decrease property values. Will you (the city) be subsidizing the destruction of our property values. Ultimately, there will be less tax collected for the city along with the decrease in land values.
6. An argument could be made that there is more traffic on Chapel Hill Road. However, the existing subdivisions have been there for 15 plus years out to Scott Blvd. I personally have not seen the increase in traffic.
7. Have you considered the effect on the preschool at the corner of Fairview and Chapel Hill? They have a historic building on a small piece of land. Parking as parents walk and discharge kids to school already makes for Fairview road congestion. There is no room for a parking lot. Walking kids safely to school should be a high priority.
8. Five or so years ago this same proposal was put forward with little support. It still garners little support. It is the wrong place to put a roundabout and the wrong place to decrease our property values. It is not a safe proposal for pedestrians and does not enhance our city.

I oppose the roundabout at Fairview and Chapel Hill.

Subject: Proposed Roundabout at South Fairview and Chapel Hill Roads

My name is Bill Edwards and my wife and I live at 1700 S Fairview Road and are being directly impacted by this mistaken need for a roundabout. I am opposed to its construction now or at any time in the future.

Roundabout Points

Point 1

At the informational meeting in December 2023, I was told that a primary reason for building a roundabout was for safety concerns. I was told by multiple city representatives and our council member that QUOTE "... four or more accidents occur at this intersection annually..."

I have lived at my address for 27 years this coming March. I can, with all honesty, tell you that I have never seen nor heard of an accident occur, be processed or towed away – never. None of my neighbors can recall an accident occurring.

I request the city to be transparent and list out all police incident / accident reports that have occurred at this intersection as far back as police records permit.

Point 2

At the informational meeting in December 2023, I was told that a primary reason for building a roundabout was to alleviate traffic congestion and that a "study" had been conducted that justified the need. No details of this study were given other than "consultants" were engaged. The ONLY congestion that needs to be alleviated occurs from 7:30am to 8:45am and again between 4:15pm to 5:50pm. This congestion is not only negligible in its occurrence, but it is insignificant in terms of length of delays.

I did my own assessment of traffic during evening rush hours for the two weeks leading up to the informational meeting. My assessment made note of traffic congestion (stopped vehicles) backed up heading west. I did this every weekday (MF).

Afternoon between 3:15 to 4pm

At no time did traffic form a line, of more than 3 vehicles, from any direction; traffic consistently moved through the intersection as a stop and go

Evening between 4:15pm and 6pm

@4:15 to 4:30 light traffic with occasional buildup reaching Handley; vehicles getting through intersection in under one minute

@4:45pm to 5:00pm little traffic with no buildup; most vehicles getting through intersection with a stop and go at the intersection

@5:15pm to 5:40pm heavy traffic with buildup extending beyond Handley; vehicles typically moving continuously with some days having stop and go beginning at Handley up to intersection; vehicles getting through intersection in under 1 ½ minutes even with stop and go lines

@5:50 and on little traffic with no build up; most vehicles getting through intersection with a stop and go at the intersection

Morning between 7:30am and 9am

Traffic quickly built up but never amounted to a steady stream of vehicles; had periodic buildup of 3 to 5 cars that quickly moved through the intersection in under 30 seconds never more than 45 seconds

@8:45am and on little traffic with no build up; most cars getting through intersection with a stop and go

I drove during these rush hours for 15 years. There were days when the west-bound traffic was stop and go, beginning at the bottom of the hill / creek. It took several minutes to get through the intersection, but this was not routine – most of these extended times occurred with snow on the road. Having a roundabout will NOT improve these infrequent occasions.

I request the city to be transparent and provide the details of the study that was conducted and justified the need for a roundabout.

Point 3

At the informational meeting in December 2023, I was told that the roundabout will require the partial demolition of my subdivision's entry wall and the entire center island at the subdivision's entrance. Our neighborhood currently has both electrical and water lines that run from the southeast entrance wall to the center island and on to the southwest entrance wall.

The neighborhood association just paid a significant price to have these two walls repaired and associated lighting replaced.

Should this project be approved, we will expect the rebuilding of these walls and their lighting, the center island, and all electrical and irrigation systems. This rebuilding will have to be accepted by the neighborhood association and entirely paid for by the city.

Point 4

As I have already noted, I have lived in my home for 27 years and I expect to be here for quite some time – unless this roundabout causes significant issues. I have already discussed the proposal with a local realtor. I was informed that this project will negatively impact the sale price of my property. I have already engaged an appraiser and will expect the city to compensate me for the entirety of any diminished value created by this project if it is implemented.

Question 1

Drainage on south side

Since the city installed the handicap sidewalk corners, I have sent multiple emails and have spoken to 2 city employees about the water drainage running down the southeast sidewalk. This is a serious problem during the winter when rain and snow melt consistently freezes over the sidewalk. This affects the sidewalks as part of the neighborhood common ground and my own property is being eroded. Will this be FINALLY corrected?

Question 2

New sidewalk from Fairview east to Handley

Once completed, will the children in the Handley neighborhood lose their school bus services as they will have a "safe" sidewalk and they will be inside the non-service zone of 1 mile? My daughters were not allowed school bus services because of the 1 mile, non-service zone; even though they would have to cross this unguarded intersection.

I would appreciate your attention to these concerns.

As residents of Chapel Hill Estates, the following discussion points are raised concerning the proposed roundabout project for Fairview Road and Chapel Hill.

1. While roundabouts are touted for their safety, this intersection contradicts standard roundabout use.
2. **Vision:** It is at the **crest of a hill** limiting site for the westbound traffic, which is the highest volume. There is no reason to believe that the traffic peak would not still back-up on the hill.
3. **Traffic:** There is a **preschool at the northeast corner** which uses **street parking** on Fairview to drop-off and retrieve children **multiple times a day**. This is a huge concern.
4. **Is safety the reason?** All prior studies have noted this intersection has never been a collision/safety concern, so why would spending \$1.2 million make it safer?
5. **Will make walking to fairview with children MORE Difficult.** I walk my children to fairview elementary from our neighborhood and at least once a week someone doesn't stop at the intersection. At every roundabout the pedestrian is the last thought of the design or driver. No one slows down at those. Thus, the roundabout will make that walk more unsafe than it already is.
6. **Inadequate Data:** The current study promoting this roundabout is based on a single traffic study from a 24-hour period on March 17, 2022, which shows a single timeframe of higher volume from westbound traffic at 4:45 p.m. It did not provide data on how long this backup lasts, which is roughly 45 minutes during weekdays only.
7. The study cited traffic growth at the intersection between 2011 and 2022 at 1.1 to 1.2%, yet future projects inflated the rate to 1.5% over 20 years. Given the fully developed nature of this area, the projected increase of traffic seems unrealistic.

As a final comment, this proposed roundabout was opposed as **not needed in 2016** and the area has not changed since then, so it is **not needed in 2024**. We were told an updated evaluation and report or proposal would be provided if this issue was raised again. This is the same.
