Has anyone of local, regional, or national historic note ever occupied the property? If so, whom? The land was owned by Garth, Ridgeway, Stephens, and Turner. It was part of the first Turner-Stephens Subdivision.

Does the property have any notable or unusual architectural qualities? If so, please identify. The style of the house is late Victorian. It has the original fish-scale trim on the eaves. The oak studs are true 2" x 4". There were no closets in the home originally. It has bulls-eye door and window trim and 10' ceilings in the original part of the house.

Have any recent renovations been performed that have helped restore the property? If so, describe them briefly. The property has not been restored to original condition but has been well maintained. Siding was added in the mid-1980's, and an addition was built at the back of the house in 1990.

Is the property recognized by any other historic preservation organizations? If so, please identify. No.

Please describe any other unusual or interesting attributes or stories about the property. It was my understanding that the original owners of the home gave it to their daughter, Amelia, and built the home next door. I have assumed that is the origin of the street name. The land was part of a 240-acre property owned by Mr. Stephens which ran from Broadway to Paris Road. This land was subdivided beginning in the 1860's or 1870's. Mr. Stephens also donated the land on which Stephens College was built. In reviewing the land deed, there were several lawsuits involved with the property, one of which involved the C. B. Miller Shoe Company.
