SECOND AMENDMENT to the CROSS COUNTRY RUNNING COURSE FACILITY USAGE AGREEMENT BETWEEN THE CITY OF COLUMBIA, MISSOURI, AND THE CURATORS OF THE UNIVERSITY OF MISSOURI

This Second Amendment to the Facility Usage Agreement is made as of the date of the last signatory noted below, between the CITY OF COLUMBIA ("City"), and The Curators of the University of Missouri ("University").

RECITALS

- A. WHEREAS, on January 18, 2019, City and University entered into a Facility Usage Agreement ("Facility Usage Agreement") related to the Cross Country Running Course at Gans Creek Recreation Area; and
- B. WHEREAS, on May 21, 2019, the Parties entered into a First Amendment to the Facility Usage Agreement; and
- C. WHEREAS, the Parties hereto desire to formally amend the Facility Usage Agreement as previously amended with this Second Amendment (hereinafter "Second Amendment to the Facility Usage Agreement") and desire to be bound by the terms contained in the Facility Usage Agreement as previously amended, and as amended by the terms contained in this Second Amendment to the Facility Usage Agreement.

<u>AMENDMENT</u>

NOW, THEREFORE, in consideration of the mutual benefit to be derived by the parties, it is agreed to amend the Facility Usage Agreement as previously amended, as follows:

- 1. Section 2 of the First Amendment shall be removed and replaced with the following:
 - "University and City have worked together to prepare architectural plans for bidding and construction of the indoor building at the Gans Creek Recreation Area cross country course. City shall be responsible for all aspects of bidding and construction of the building including site preparation, issuing of building permits, utilities installation, building construction and site restoration at the conclusion of the project."

- 2. Additional Contribution. University shall contribute an additional \$100,000 to the completion of the indoor building.
- 3. All other terms of the Facility Usage Agreement as previously amended shall remain unchanged and in full force and effect.
