AGENDA REPORT PLANNING AND ZONING COMMISSION MEETING December 9, 2021

SUMMARY

A request by A Civil Group (agent), on behalf of New Haven Custom Homes LLC (owner), for a one-lot final minor plat to be known as Lakeview Plat 1. The subject site is zoned R-MF (Multi-family dwelling) and is located on the north side of Lakeview Avenue, approximately 700 feet east of Range Line Street. (Case # 30-2022)

DISCUSSION

The applicant is seeking approval of a one-lot final minor plat to be known as *Lakeview Plat 1*. Staff understands a single-family structure existed on the subject site until approximately 2020 when it was lost to structure fire. The applicant's intent is to bestow legal lot status to the now vacant site for the purposes of constructing a new structure. The 0.18-acre site is located on the north side of Lakeview Avenue from which it takes access.

The vacant site does not contain any existing encroachments relating to the R-MF zoning district. This plat does not create any other non-conformities in relation to the zoning standards of the UDC. Development will conform to the dimensional standards and regulations of the R-MF zoning district.

Lakeview Avenue currently has a 50' right-of-way which conforms to the street standards for a local, residential street per the UDC. Additional right-of-way dedication is not required. Sidewalk does not exist along the street frontage and will be required to be constructed by the owner when the site is developed. A standard 10' utility easement is being dedicated by the plat. The site is served by all City utilities and requires no other public utility infrastructure expansion at this time.

The proposed final plat has been reviewed by staff and it meets all requirements of the Unified Development Code.

RECOMMENDATION

Approve the requested final minor plat of *Lakeview Plat 1*, subject to minor technical corrections (i.e. technical surveying matters such as legend notation)
