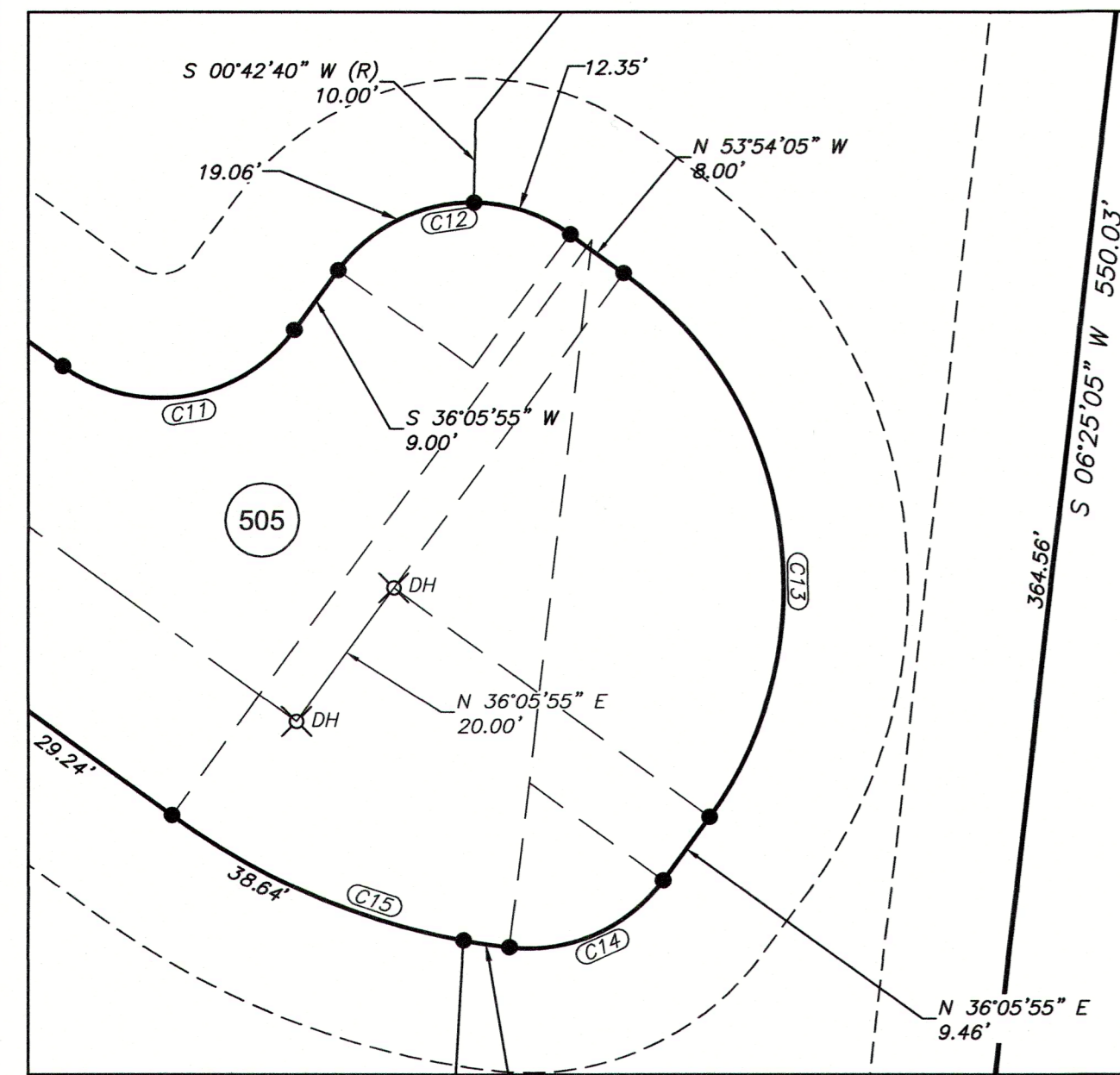


ARBOR FALLS PLAT NO. 4

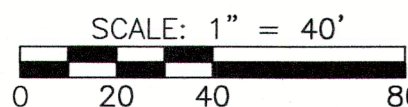
LOCATED IN THE NORTHEAST 1/4 OF SECTION 22, TOWNSHIP 48 NORTH, RANGE 12 WEST

NOTES

1. ALL CURVE LENGTHS ARE ARC LENGTHS UNLESS OTHERWISE NOTED AS CH. FOR CHORD DIMENSIONS.
2. A CURRENT RECORD TITLE COMMITMENT WAS NOT PROVIDED FOR THIS PLAT.
3. THIS SURVEY CONFORMS TO THE ACCURACY STANDARDS FOR URBAN PROPERTY AS DEFINED BY MISSOURI CODE OF STATE REGULATIONS 20 CSR 20.30-16.040 (2)(A).
4. LOT 437 SHALL BE PROHIBITED FROM TAKING DRIVEWAY ACCESS ONTO PERGOLA DRIVE.
5. THIS TRACT IS SUBJECT TO LANDSCAPING AND STREET TREE REQUIREMENTS PER CHAPTER 29-4.4 CITY OF COLUMBIA CODE OF ORDINANCES. THIS REQUIREMENT IS LOCATED ALONG THE SOUTH RIGHT-OF-WAY OF PERGOLA DRIVE.
6. A 10 FOOT WIDE EASEMENT FOR WALKING TRAILS/PEDWAYS HAS BEEN DEDICATED IN PLAT BOOK 40, PAGE 86 OF THE BOONE COUNTY RECORDS. SAID EASEMENT ORIGINALLY LIED NORTHERLY OF AND ADJACENT TO THE ROUTE WW RIGHT-OF-WAY.
7. ALL MAINTENANCE OF THE PRIVATE STREETS SHOWN ON THIS PLAT SHALL BE THE RESPONSIBILITY OF THE OWNERS ASSOCIATION OR ADJOINING PROPERTY OWNERS. NO PRIVATE STREETS SHALL BE DEDICATED TO NOR ACCEPTED BY THE CITY FOR MAINTENANCE UNTIL THEY HAVE BEEN IMPROVED TO MINIMUM CITY STANDARDS FOR PUBLIC STREETS.
8. EULISS DRIVE TERMINATES WITH THE LAST LOT FROM ARBOR FALLS PLAT 3, WE MULLIGAN LANE BEGINS WITH THIS DEVELOPMENT FOR LOT 417 AND LOT 418.
9. THERE ARE FIVE COMMON AREA LOTS (501, 502, 503, 504 & 505) WITH THIS PHASE OF ARBOR FALLS. COMMON AREA 502 & 505 CONTAIN THE PROPOSED PRIVATE STREETS.
10. THE PRIVATE STREETS ON THIS PLAT ALSO CONSIST OF A UTILITY EASEMENT. A 15' UTILITY EASEMENT SHALL BE PLATTED ADJACENT TO BOTH SIDES OF THE PRIVATE STREETS.

FLOOD PLAIN STATEMENT

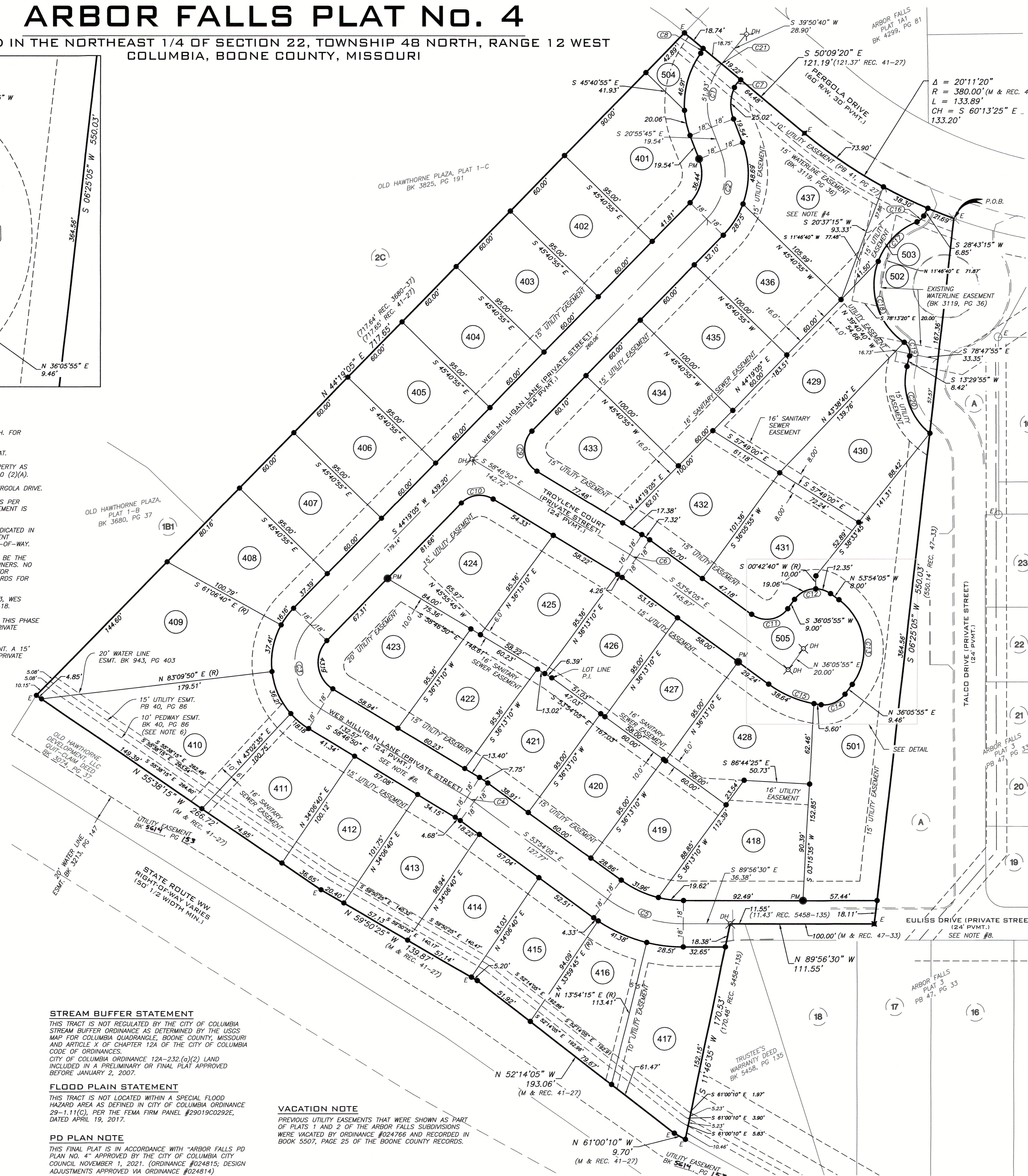

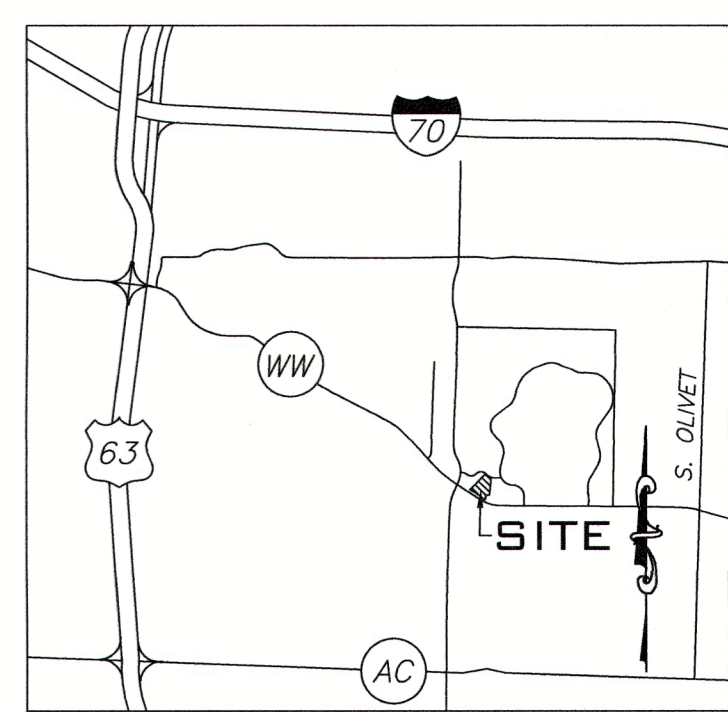
VACATION NOTE
