Re: Approving an ARPA funding agreement for Columbia Housing Authority's Park Avenue

Project

#### **Executive Summary**

Approving this ordinance will appropriate funds and authorize an ARPA funding agreement in the amount of \$2,000,000 for Columbia Housing Authority's Park Avenue Project. The Council declared its commitment and intent to support this project with up to \$2,000,000 in ARPA funding on September 6, 2022 in conjunction with its support of Columbia Housing Authority's application for low-incoming housing tax credits for the financing of the project. The funding will be provided as a 0% interest loan due upon transfer of title, and forgivable after 20 years.

#### Discussion

As part of the American Rescue Plan Act (ARPA), the City received \$25,284,624 in Coronavirus State and Local Fiscal Recovery Funds (SLFRF). SLFRF funds may be used to replace lost public sector revenue; support the COVID-19 public health and economic response; provide premium pay for eligible workers performing essential work; and investments in water, sewer and broadband infrastructure. The U.S. Treasury recognizes that the development of affordable housing and permanent supportive housing are eligible uses to respond to the impacts of the pandemic on households and communities.

Columbia Housing Authority (CHA) and its partner entity, the Park Avenue Housing Development Group, LP, plan to replace existing units with family site units. The existing units were constructed in 1964 and have exceeded their life cycle. The existing units have significant problems with collapsing sewer lines, foundation problems, and electrical issues. Additionally, there is a need for improved accessibility and energy efficiency. CHA's current plan includes the demolition of all 70 units and the construction of new, modern, and energy efficient housing. The proposed project will include 79 units consisting of 22 one bedroom units, 36 two bedroom units, 15 three bedroom units, and 4 four bedroom units. This project will comply with the HUD Broadband Rule.

On September 6, 2022, the City Council passed Resolution R132-22A expressing support for the replacement of downtown public housing units on Park Avenue and committing up to \$2,000,000 in ARPA funding for the Park Avenue Project. CHA will use these funds, in addition to other funding, including low income tax credits, for the project. The \$2,000,000 will be provided in the form of a forgivable loan and will commit CHA to keeping the housing units affordable for a period of twenty years. The terms are structured in accordance with the U.S. Department of the Treasury's Affordable Housing How-To Guide for Affordable Housing Production and Preservation.

## Legislative History
