Re: Authorizing a Call for Bids through the Purchasing division for the remodel of the repurposed Automated Flight Service Station Building at Columbia Regional Airport.

Executive Summary

Authorizing a call for bids through the Purchasing division for the proposed remodel of the repurposed Automated Flight Service Station (AFSS) building located at Columbia Regional Airport for the purposes of a rental car facility, airport administration offices, and future Transportation Security Administration (TSA) offices.

Discussion

The repurposed Automated Flight Service Station (AFSS) building located just south of the new Airport terminal will be remodeled to house airport administration offices, car rental space and the future Transportation Security Administration (TSA) offices.

Burns & McDonnell Engineering Company, Inc. was awarded the contract for design services in the amount of \$378,275. The estimated cost to complete the project is \$4.8M, which includes:

Remodel construction of the building \$4,000,000
 Parking lot in front of the building \$400,000
 Engineering Construction Phase Services \$400,000

An Interested Parties meeting was held at City Hall on August 10, 2022, with two individuals in attendance, and a public hearing is scheduled for May 6, 2024. If City Council approves moving forward, construction will begin this summer.

Fiscal Impact

Short-Term Impact: Improvement costs for the remodel of the AFSS building are estimated to cost \$4.8M for construction, parking lot improvements and engineering construction phase services, to be paid from the Terminal project AP111.
