### Accounting

The Accounting Department received its plaque for the GFOA Certificate of Achievement for Excellence in Financial Reporting for the City of Columbia's FY22 Annual Comprehensive Financial Report. This is the 43rd consecutive year to have received this prestigious award, which is a testament to the hard work and dedication of our accounting staff and management.

### **Business Licensing**

The business license renewal season is kicking off. Renewal notices will be delivered to all liquor license holders in the coming weeks, as those renewals are due by May 1 in order to avoid late fees. General business license renewal notices are expected to go out in late April, well ahead of the June 30 license expiration date, although electronic notices may be sent prior to that in order to encourage early, online renewal.

### Economics

We have begun to publish our monthly Economic Report for the City of Columbia on the city website. #### Grants

Currently 47 Grants have been awarded for \$64,792,738. During the month of February a single competitive grant was submitted. It was a RAISE Grant submitted to USDOT for a project total of \$3,133,968. If awarded it will help with the I-70 Business Loop Corridor Study. The City did not receive any awards for the month of February.

### **Risk Management**

Our office initially administered 12 auto claims and 7 injury claims since the beginning of February.

We plan on conducting and Severe Weather and Evacuation Safety for the 2nd quarter. Chief John Ambra from the Columbia Fire Department will be assisting Risk Management with this training. We plan on conducting Hazard Communication for 3rd quarter safety training. For the 4th quarter, our IT staff will be assisting with Cyber Security training.

### Treasury

Approximately 6,900 customers (8,200 utility accounts) are currently remaining on a City AutoPay plan, and there are approximately 9,700 customers (11,000 utility accounts) enrolled on a PayCoMo AutoPay plan as of 4:30 pm on 3/07/24.

Enrollments for PayCoMo have been largely unassisted. Within one month of the feature being live, 6,500 customers (38% of original enrolled customer volume) enrolled to the platform and that amount has increased by approximately 20% in the 10 days since.

Finance and all City Staff are taking feedback and comments from customers sincerely, and incorporating changes as enhancements to the platform as much as possible. As our work with Paylt is anticipated to grow and develop over the next few years, we will continue to improve the platform for all City payments.

Finance would like to give a special thanks and recognition to front-line customer service staff in Treasury Management, Utility Customer Service and the Contact Center. As we work through this change with our customers and educating customers on their utility payment options, the front-line staff service has been exemplary. We wish to communicate to Council and City Management that the staff will continue to be available to customers throughout, and beyond this transition for payment inquiries and needs.

### **Financial Report**

Attached is the quarterly report for the first quarter of fiscal year 2024. On average, the City receives 97% of the budgeted property tax revenue in the first quarter of every year.

Also, an update for the PayCoMo AutoPay conversion is attached for your review.
