### **Executive Summary**

Request to amend the FY 2024 budget personnel summary and the Classification/Pay Plan to create new classifications, reassign classifications, change a classification title, and revise classification titles to designate union representation as a result of voluntary recognition previously approved by the City Council.

### Discussion

On October 16, 2023 the City Council approved recognition of identified classifications in the Water Distribution Division of the Utilities Department as an additional work unit of LiUNA Local 955 bargaining Unit. At this time, it is requested to revise classification titles and reassign classifications to reflect the change in representation from Water and Light Association to LiUNA Local 955. The following classifications are impacted by this change: Utility Locator I, Utility Service Worker I, Water Distribution Operator I, Water Distribution Crew Leader, and Water Distribution Technician. There is separate legislation to amend the Collective Bargaining Agreement with Local 955 to incorporate identified Water Distribution classifications. There is separate legislation to amend the Collective Bargaining Agreement with LiUNA Local 955 to incorporate identified Water Distribution classifications.

Additionally, on January 16, 2024 the City Council approved recognition of identified classifications in the Electric Production and Electric Distribution Divisions of the Utilities Department as members of the Water and Light Association bargaining unit. At this time, it is requested to revise classification titles to reflect representation by the Water and Light Association and to have consistent titling with the NERC Certified System Operator and Apprentice classification. The following classifications are impacted by this change: Apprentice Balancing Authority Operator, Electric Distribution Coordinator, and NERC Certified System Operator.
