B.1. Organizational Mission Statment

Through empowerment, education and partnerships, The Food Bank for Central & Northeast Missouri brings together community resources to feed people in need.

B.2. Description of Organizational Goals

The Food Bank's primary goal is to reduce food insecurity and its devastating consequences. A few indicators of success in 2023 include:

- The distribution of approximately 30 million pounds of food or enough to meet the need
- 100,000 neighbors served monthly through partner agencies and programs, including 10,000 Boone County residents each month at The Food Bank Market (formerly Central Pantry)
- Increased distribution of nutritious foods, at least 25% of which is comprised of fresh produce
- The completion of The Food Bank Market building project and grand opening

B.3. Describe the geographic service area.

Central Pantry is currently located at 1007 Big Bear Boulevard. In late fall of 2023, Central Pantry will be rebranded as The Food Bank Market and relocated to 705 Business Loop West. Food-insecure neighbors from across all of Columbia and Boone County will be served at this more centralized and accessible location.

The Food Bank, the organization that owns and operates Central Pantry/The Food Bank Market, serves neighbors in a 32-county service area that covers more than 18,000 square miles in central and northeast Missouri.

B.4. Describe the populations served by your organization.

Food insecurity impacts people of all ages, genders, races, ethnicities and abilities. Therefore, The Food Bank and its partners serve individuals of all demographics. Some populations are at a higher risk of experiencing food insecurity and its negative effects. For this reason, The Food Bank operates programs targeting food-insecure children, teens, seniors, veterans, the unhoused and those living in rural areas. Roughly 98% of those served live at or below 200% of the federal poverty level.

D.1. Provide a summary describing the proposed project.

The Food Bank is renovating the empty Moser's Foods on Business Loop 70 West to relocate its Central Pantry. This centralized and accessible facility will provide low-income neighbors access to supplemental food aid, nutrition education, community meeting space and opportunities to receive services (like healthcare) from various partners. Central Pantry will be rebranded as The Food Bank Market (TFBM) and will provide a grocery store experience to reduce the stigma associated with food pantries.

To improve the resilience of the new building, The Food Bank will utilize an award of \$199,269 in CDBG funds to purchase and pay for the installation of a backup generator. It will allow The Food Bank Market to maintain safe food temperatures in the 5,100 square foot freezer and 2,400 square foot cooler during electric outages, preventing the loss of hundreds of thousands of pounds of nutritious food. It will also allow this vital public facility to remain open and operational when Columbia neighbors are without power and require supplemental food.

When disasters strike in mid-Missouri, The Food Bank works round-the-clock to distribute nutritious foods, clean water and other necessities to all in need. Low-income neighbors are especially vulnerable to disasters as they often lack insurance and social supports. With a backup generator, The Food Bank Market will serve as a reliable hub for resources in times of crisis.

As of May 2023, The Food Bank has raised 64% of the total cost to renovate and relocate The Food Bank Market. The organization will go public with its capital campaign to raise the remaining funds on May 25, 2023. This is the perfect time and opportunity for The City to invest in food security infrastructure. By funding this generator, The City will also protect its purchase of service contract with Central Pantry/The Food Bank Market for more than 428,000 pounds of food annually, 55% of which requires cold storage.

The Food Bank Market will benefit at least 20,000 individuals annually in the new location. In 2022, 22,111 individuals received assistance at Central Pantry – 78% were City of Columbia residents and 92% were Boone County residents. The target population is low-income Columbia and Boone County residents who are experiencing food insecurity.

D.5. Outcomes: Identify the specific, measurable and desired outcomes for this project.

1. TFBM will reduce food insecurity among low-income neighbors by providing reliable access to sufficient nutritious food

80% of survey respondents agree that receiving food from TFBM gave them a meal when they would have otherwise had none

2. TFBM will increase the consumption of healthy foods among low-income neighbors by offering nutritious food options 80% of survey respondents agree that receiving food from TFBM helped their household eat more healthfully

Paper surveys are disseminated twice annually to 100 random Food Bank Market patrons. The surveys include the two outcome measures listed above.

By providing free supplemental food in a low-income area, The Food Bank Market is building infrastructure that supports social and racial equity. The food is not only free but nutritious, reducing diet related illnesses common in low-income families. Partners will provide assistive services on site.

Central Pantry patrons were surveyed in the fall of 2021 regarding a new facility. Results from the survey were considered when developing plans. The Food Bank's CEO also spoke with The Loop Community Improvement District to ensure The Food Bank Market would support their goals. The parties discussed what missing services could be provided and which existing services should not be duplicated. The Transit and Parking Office was contacted regarding adding a bus stop in front of the new location.

Coil is experienced in all facets of commercial construction.

SOA Architecture – has provided full-scale architectural services to take projects from initial concept through construction since 1987.

D.16. Provide a brief summary on previous City funding received, any funding remaining, and the measurable results from previous City funding.

The Food Bank received a \$19,000.00 CDBG award from the City in 2019 to make improvements to Central Pantry. Lighting fixtures were replaced with energy efficient LEDS with occupancy sensors. New HVAC ductwork and thermostat were also installed to improve the heating and cooling system. These improvements reduced Central Pantry's energy use by 15,000 kilowatts annually. All of the awarded funds were spent on the project.

The Food Bank received a \$123,000.00 CDBG-CV3 award from the City in 2021 for the acquisition and distribution of food to low and moderate income that experienced a reduction in income and employment due to the COVID-19 Pandemic. The full amount was billed for food before December 31, 2022. An additional award of \$13,740.00 was fully spent on food before December 31, 2022



The Food Bank was awarded funding through a contract agreement with the City of Columbia Social Services Department for the acquisition of nutritious food for Central Pantry. The organization was awarded \$30,000.46 in FY2022, \$30,000.00 in FY2020, \$30,000.00 in FY2018 and \$50,000.00 in FY2017. With the help of this funding, Central Pantry distributed roughly 1,500,000 lbs. of fresh produce, 500,000 lbs. of protein, and 180,000 lbs. of dairy, annually. All of the awarded funds were spent within each funding cycle. The organization is in the middle of the FY2023 cycle with an award of \$30,000.46 for food distributed at Central Pantry and \$95,311.46 for food distribution to The Food Bank's partners in Columbia.

The City of Columbia has generously supported The Food Bank's mission for many years, and for that The Food Bank is extremely grateful. With record-breaking food costs, building materials, fuel and more, The Food Bank will continue to need the essential support of its partners in order to meet the current and increasing needs of the community.


