Re: Authorizing a Supplemental Agreement to the Airport Aid Agreement with the Missouri Highways and Transportation Commission relating to Taxiway C2 and Apron Expansion

Project at Columbia Regional Airport

Executive Summary

Staff is requesting Council authorize the City Manager to execute a supplemental agreement to the Airport Aid agreement with the Missouri Highways and Transportation Commission (MHTC) relating to the reconstruction of Taxiway C2 and Apron Expansion project at Columbia Regional Airport.

Discussion

On August 3, 2020, Council Bill 191-20 was passed authorizing an Airport Aid agreement with MHTC relating to the reconstruction of Taxiway C2 and the apron expansion at the Columbia Regional Airport, at an estimated cost of \$1,442,786. The agreement allowed for MHTC to reimburse the City 90% of the cost, or \$1,298,507.

The Airport Aid agreement expired December 31, 2021, which was prior to the submittal of the engineer's project closeout report in May of 2022 and staff's final reimbursement request in the amount of \$8,355. Therefore, staff is requesting that Council authorize the City Manager to execute a supplemental agreement with MHTC extending the project period to December 31, 2022. A request for Council to approve the amendment along with an explanation and request that all actions taken by city staff prior to execution of the amendment be ratified.
