Re: Authorizing a Bid Call for the Construction of Oakland Gravel Road Sidewalk Project

Executive Summary

Staff is requesting council authorize a bid call through the Purchasing Division for the construction of a sidewalk along the west side of Oakland Gravel Road in northeast Columbia. An Interested Parties (IP) meeting was held on June 7, 2022. The public hearing was held on September 6, 2022.

Discussion

The Oakland Gravel Road Sidewalk project design will include the following improvements: (a) Construction of a concrete sidewalk to fill in sidewalk gaps along the west side of Oakland Gravel Road between Vandiver Drive and Grizzly Court.

- (b) Reconstruction of two concrete islands and installation of audible pedestrian system (APS) signals crossing Oakland Gravel Road at the intersection with Vandiver Drive.
- (c) Reconstruction of several sidewalk ramps and landings to meet ADA requirements.

An Interested Parties (IP) meeting was held on June 7, 2022. The public hearing was held on September 6, 2022.

The total preliminary cost estimate for this project (design, easements, and construction) is \$266,000. The project will be funded with the ½-cent Capital Improvement Program sales tax. The project is scheduled for construction in summer of 2023.

Fiscal Impact

Short-Term Impact: The total preliminary cost estimate for this project (design, easement, and construction) is \$266,000. The project will be funded with the 1/4-cent Capital Improvement Program (CIP) sales tax.
