Re: Asset Forfeiture

Executive Summary

Council requested a report on the Federal Asset Forfeiture Program as it relates to the Columbia Police Department.

Discussion

The Columbia Police Department (CPD) participates in multiple Federal Task Forces used to target criminals who prey on the vulnerable in our community. Officers assigned to these Federal Task Forces assist in federal investigations that sometimes result in the seizure of assets by the federal government that are used in the commission of crimes. The seizure of these assets is authorized by the U.S. Department of Justice's Asset Forfeiture Program. According to the Department of Justice's Guide to Equitable Sharing, these asset forfeitures are authorized to be shared with cooperating state and local law enforcement agencies through the Equitable Sharing Program. CPD receives Equitable Sharing Funds from the Departments of Justice and Treasury after a federal case has been adjudicated and the assets have been authorized for release according to Department of Justice rules.

The CPD Command Staff has discussed various uses for these funds based on current needs, including: equipment upgrades/additions, marketing services to support recruiting plans, a training simulator, and technology to support efforts to deter/detect/investigate crime issues throughout the community, especially those that are violent in nature.

It is important to note what these funds can and cannot be utilized for per program rules:

Permissible uses include:

- Law Enforcement Investigations
- Law Enforcement Training
- Law Enforcement and Detention Facilities
- Law Enforcement Equipment
- Law Enforcement Travel and Transportation
- Law Enforcement Awards and Memorials
- Drug and Gang Education and Awareness Programs
- Matching Funds for state/federal grants
- Transfers to Other Law Enforcement Agencies

Impermissible uses include:

- Salaries for positions exceeding one year
- Use by non-law enforcement personnel
- Payment of education-related costs
- Non-official government use
- Purchase of food or beverages
- Extravagant expenditures
- To replace or supplant the appropriated resources of the recipient
